It's important to note that businesses are required to provide accurate information about the services they offer under the FCCC Act. This includes warning customers about any potential legal issues that may arise from the modifications. Failing to do so may leave businesses liable, and consumers have the right to file complaints if they believe they've been misled.

Before engaging with a business that offers modifications, consumers should ask the following:

- Is this modification legal under Fiji law?
- What are the potential risks if my vehicle is stopped by the authorities?
- Will the modification affect my insurance?
- Is the business offering any guarantee or warranty for the work?

Consumers also have the right to demand that businesses offer safe, legal, and fully disclosed services. If a business does not clarify the risks of an illegal modification, it could be a violation of consumer protection laws, and those affected should seek recourse through the relevant authorities such as the LTA or the Fiji Competition and Consumer Commission (FCCC).

1. Financial Consequences:

Consumers who modify their vehicles without adhering to the Land Transport Authority's (LTA) requirements can be subject to significant fines. These penalties are enforced to ensure public safety and compliance with road regulations. Additionally, vehicles with illegal modifications may fail mandatory safety inspections, which are required for continued use on the road. If a vehicle does not pass these inspections, owners will need to spend more money to either reverse the illegal modifications or make the necessary adjustments to meet LTA standards, further increasing their financial burden.

2. Insurance Voids:

Most insurance policies include clauses that void coverage if a vehicle has been illegally modified. This means that if your vehicle is involved in an accident and the illegal modifications are discovered, your insurance company may refuse to cover the damages or any liability. As a result, you would be personally responsible for paying for repairs, medical expenses, and any other costs arising from the accident. This lack of coverage not only increases your financial risk but also leaves you vulnerable to legal consequences, especially if others are involved in the accident.
