### **Potential Problems – Case Studies**

Hiring an unqualified individual to design and plan your home can lead to several problems, including substandard designs, financial losses, structural issues, and even safety hazards. Without due diligence, consumers risk engaging people who lack the necessary skills or fail to adhere to global standards. These mistakes can result in poorly designed structures, legal complications, and wasted time and money.

Here are some real-life examples to illustrate the issues Consumer Council of Fiji has received over the past two years:

### **Case Study 1**

In 2021, Mr. X engaged an individual was not a registered architect, to draw up plans for his dream home. While the initial concept was finalized according to the architect, it was not released to the client. Despite making all payments, Mr. X was kept waiting for almost a year, with the provider repeatedly saying 'it will be done soon.' After a year, the service provider finally delivered the plan following a complaint lodged with the Consumer Council of Fiji. This delay highlights the importance of setting clear deadlines, ensuring accountability when hiring professionals and making full payments only after you have received the finalized plan.

#### **Case Study 2**

Mrs. H hired an unregistered architect to design her family home and paid 50% upfront. However, the designer later demanded additional fees for amendments to the plan, claiming these were outside the initial agreement. Mrs. H discovered there was no signed contract, leaving her with little recourse. This case underscores the need to have a clear and legally binding agreement before beginning any work, which outlines any additional charges, and the full scope of work inclusive of any edits or changes.

#### **Case Study 3**

Mr. Y came across an advertisement on Facebook by an individual who was holding himself out to be a registered architect. He engaged with this person to design two executive rooms and paid a 50% deposit upfront. Initially, communication was smooth, and the designer promised timely delivery. However, delays soon followed, and the architect eventually stopped responding. Mr. Y was left without the promised design, illustrating the risks of trusting unverified service providers. The matter was then deferred to the Fijian Competition and Consumer Council for further investigation.

Each of these cases highlights the challenges consumers can face when engaging unregistered or unreliable service providers. The lessons are clear: always verify credentials, have contracts in place, and ask around to verify the reputation of a service provider to avoid such pitfalls.

Investing in a registered architect ensures that your home is built with integrity, precision, and compliance with local regulations.

### How to Verify an Architect's Credentials

The ARB's list of registered architects is publicly accessible, making it easy for consumers to confirm a professional's credentials. Before engaging an architect, ask to see their registration certificate or cross-check their name against the ARB's official list.

• **Do Your Research:** Read reviews and ask for referrals to understand an architect's reputation and track record.
